(Application Deadline: May 18, 2025)

To apply for financial assistance from the **Ottawa Islamic Soccer League**, please follow these instructions:

- 1. Determine if you qualify financially for assistance by referring to the eligibility criteria below.
- 2. Complete, sign, and submit this application by the deadline. One application per family is required.
- 3. Submit completed applications via email to <u>info@ottawaisl.ca</u> or hand them in at an OISC program session.

Eligibility Criteria

| Household Size | Maximum Total (Before Tax) Family Income |

Household size represents the total number of people living under one roof.

Conditions of Eligibility

- I understand that the funds for OISC Financial Assistance come from private donations and sponsorships and may include Zakat.
- I certify that the players listed on this form are registered for the OISC 2025 Summer Season.
- I certify that our total household income does not exceed the amount identified in the table above.
- I understand that financial assistance covers a portion of program fees, and I am responsible for the remaining balance.
- I understand that financial assistance is granted based on eligibility and available funding, and all decisions are final.
- I understand that if my child receives financial assistance, they must attend at least **80% of scheduled** sessions to remain eligible.
- I understand that if selected, I may be required to provide income verification documents.
- I agree to allow OISC access to my child's participation records to evaluate the effectiveness of the program.
- I agree to release OISC from any liability in its efforts to provide financial assistance, which is **renewable annually** at OISC's discretion.
- If the number of applications exceeds available funds, **a random selection may be conducted** to determine recipients.
- Receiving financial assistance does not guarantee acceptance into the OISC program, as registration requirements must still be met.
